APPENDIX 1

LEGAL EXPERIENCE

The following are summaries of matters for which I had the primary carriage.

- 1. Acted for the plaintiff, who is a former solicitor, in a claim against his insurer, to enforce an income protection/loss of income insurance policy. The insurer purported to terminate the insurance contract on the basis of the insured's fraudulent non-disclosure of matters relating to the insured being struck off.
- 2. Acted for the plaintiff in a claim relating to the structural design of a golf course clubhouse. The claim was against the civil and structural engineer who designed the clubhouse structure, footings and adjoining civil works.
- 3. Acted for a group of 21 separate entities in defending claims by their stockbroker for monies owed. The clients brought counterclaims for losses incurred as a result of the stockbroker engaging in misleading and deceptive conduct relating to "naked options trading."
- 4. Acted for parties in recovering money owed under a contract for the sale of land. That matter firstly involved opposing the purchaser's application to set aside a statutory demand and the subsequent winding up of the purchaser. The clients then commenced proceedings against their former solicitors for a failure to take out proper security for the clients' vendor finance. That also involved an application for leave to proceed against a bankrupt.
- 5. Acted for a cattle grazier with substantial land and cattle interests in North Queensland. The matter involved defending proceedings brought by receivers and managers of a failed managed investment scheme. The responsible entity for the scheme had leased the client's cattle and agisted those (and other) cattle on the client's property. The matter involved resisting applications to remove cattle from the property and defending claims as to the ownership of certain cattle.
- 6. Acted for investors in claims against a major financial institution for losses incurred in investments in indexed share funds during the global financial crisis.
- 7. Acted for developers in an appeal to the Planning and Environment Court of a Council's decision notice.
